

# Project: Various 2018 Urban Road Detailed Design Pre-Engineering Notice

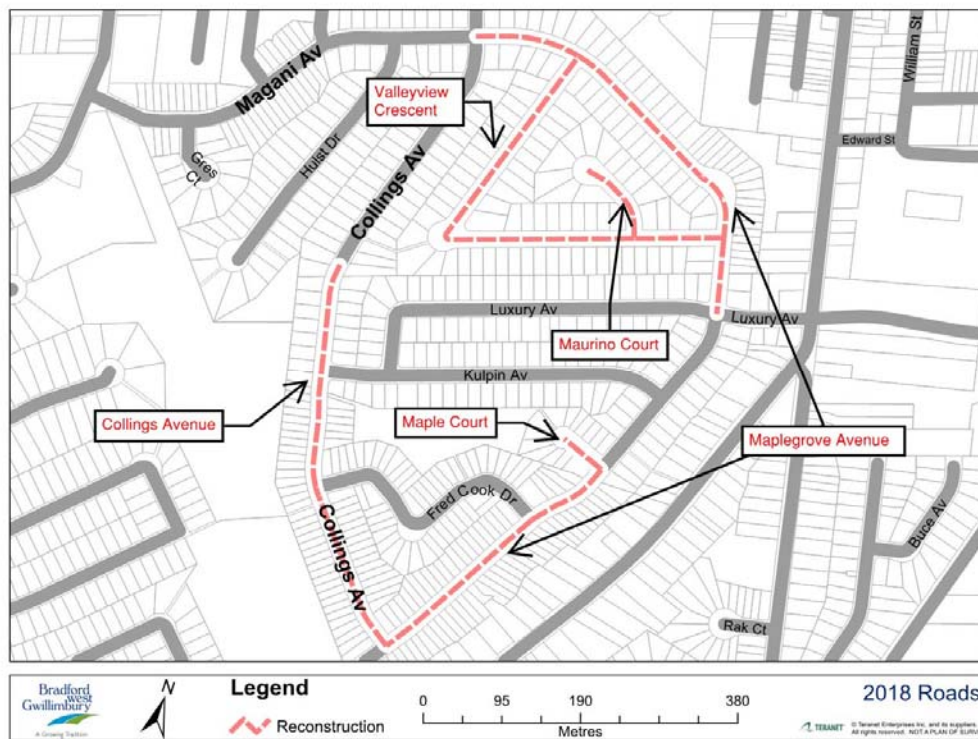

## WHAT:

The Town of Bradford West Gwillimbury has awarded the engineering design for the Various 2018 Urban Road Detailed Design project to Ainley & Associates Limited. The assignment will evaluate the existing infrastructure – including watermain, sewers, concrete curbs, sidewalks and road asphalt – to identify any that need repair or replacement.

## WHERE:

This project includes the following sections of road:



1. **Collings Avenue**  
(100 metres north of Kulpin Avenue to Maplegrove Avenue)
2. **Maplegrove Avenue**  
(Collings Avenue to Maple Court & Luxury Avenue to Collings Avenue)
3. **Maple Court**
4. **Maurino Court**
5. **Valleyview Crescent**
6. Although not shown on the map above, **Gordon Court** is included in this project.

## WHEN:

Pre-Engineering works will begin immediately and take approximately 12 weeks (August-November 2017). This includes topographic and legal survey, geotechnical field investigation, and reviewing/recording existing infrastructure and site conditions. The overall Detailed Design is anticipated to be completed by February 2018.

## HOW YOU MAY BE AFFECTED:

During the Pre-Engineering and Detailed Design phase, you may see people around your property and on your street completing field investigations. You can expect to see the following:

- **Topographic Survey** – people obtaining the vertical and horizontal alignments of existing structures including outside house corners, private gardens, walkways and trees as well as road infrastructure and utilities.
- **Legal Survey** – people obtaining, setting and confirming the location of legal property bars and Town right-of-way.
- **Geotechnical Field Investigation** – laying out and drilling boreholes to identify the existing soil conditions and groundwater elevation. This work will include traffic control people for temporary lane closures during the drilling of boreholes.
- **Review/Record Existing Infrastructure and Site Conditions** – people photographing existing conditions as well as observing and recording site conditions. This work will include traffic control during the internal review of existing storm and sanitary sewer structures (catch basins and maintenance holes).

Please be aware that all workers doing these jobs will be wearing reflective orange vests or clothing. If you have questions or concerns, we ask that you contact either the Town or our consultant at the numbers below. We apologize for any inconvenience this work may cause.
