• Every person who contravenes a provision of this By-law, including an order issued under this By-law, is guilty of an offence and, upon conviction, is liable to a fine as provided for in subsection 429 (1) and (3) of the *Municipal Act, 2001*, S.O. 2001, c.25 as amended.

- If an Owner or Operator fails to comply with this By-law, the Town may enter upon the Owner's property at any reasonable time for the purposes of remedying any contravention, including but not limited to removing the Donation Bin and any waste in the direct vicinity.
- Costs incurred by the Town in removing the Donation Bin and any waste, or matters ancillary thereto, may be recovered by action or adding the costs to the tax roll and collecting them in the same manner as taxes.

I also understand that I can, as an Owner/Person, be held responsible for any contraventions of this by-law, in accordance with Section 8.

As of the date of this application, I am the registered Owner of the lands mentioned above. I hereby allow the applicant to locate a donation bin on the lands described above. I declare that the information provided is true and correct and agree to all the rules and regulations set out in the Donation Bin By-law 2015-93.
